### **Terms of Service and Conditions of Use**

# Updated May 4th, 2020

PLEASE REVIEW THESE TERMS OF SERVICE AND CONDITIONS OF USE ("TSCU") CAREFULLY. THIS TSCU IS A BINDING LEGAL AGREEMENT BETWEEN RANCLASS S.A. (HEREINAFTER "NAXON LABS"), A URUGUAYAN CORPORATION WITH ADDRESS IN STREET COLONIA 1323 APT. 301, MONTEVIDEO – URUGUAY, AND YOU AND, IF APPLICABLE, THE COMPANY OR OTHER LEGAL ENTITY YOU REPRESENT (COLLECTIVELY, "YOU") REGARDING NAXON LABS SOFTWARE AND WEBSITE THAT YOU ARE ACCESSING OR USING (INCLUDING ANY FUTURE UPDATES, UPGRADES OR VERSIONS OF THE SOFTWARE AND/OR WEBSITE) (COLLECTIVELY, THE "SOFTWARE" OR "APPLICATION" OR "PLATFORM"), AND ANY ASSOCIATED NAXON LABS SERVICES AND ACCOMPANYING DOCUMENTS, INFORMATION, MANUALS OR OTHER RELATED MATERIALS PROVIDED BY NAXON LABS AS PART OF, OR IN CONNECTION WITH THE SOFTWARE.

How Does NAXON LABS Keep Your Information Safe? We limit access to your personal information to employees and/or authorized service providers with a need to know to fulfill their designated functions.

**Transfer of Personal Information to other Countries**. Your personal information may be collected, used, processed, transferred, and retained by us, our affiliates and our service providers in multiple countries (including for example the United States), which may be outside the region in which you are situated and may have different privacy or data protection legislation, and may therefore be subject to the laws of these countries.

How Long Does NAXON LABS Keep Your Information? We have information retention processes designed to retain your personal information only for so long as we consider necessary for the purposes set out above, and for other legitimate business purposes including considering criteria such as applicable legal requirements and statutes of limitations, the duration of your use of the Products, and the information needed to support your warranty and support requests. Typically, we will retain your NAXON LABS Services' account personal information for as long as you have an account on one or more of our Products. We will delete your personal information from our Products if your account becomes inactive, i.e., there has been no user log-in to the account for a period set by us from time-to time (such period of nonactivity will not exceed 10 years) or if you withdraw your consent to the processing of your personal information (e.g., if you delete your account). In such case, backup copies of your personal information will be removed from our cloud, however it may persist in our database for a short period (up to 30 days) due to technical reasons. Your Choices and Privacy Rights. You may have certain rights with respect to our processing of your personal information. You also may withdraw any consent you previously provided to us, e.g., by deleting any user account you have in connection with our Products or by contacting us by our contact information. If you do so, this will not affect the lawfulness of our use of your information based on your consent before its withdrawal. Please note that if you revoke your consent to use certain data, you may not be able to use our Products or certain features or functionality of our Products.

If you contact us to do any of the things listed above, we may require you to provide sufficient personal information to allow us to identify you and provide you with the requested information. We will respond to your request within a reasonable time and at minimal or no cost to you in accordance with applicable laws.

If you are not satisfied by our response or if you consider that our processing of your personal information infringes applicable law, you may lodge a complaint with a competent supervisory or regulatory authority, which may be the authority in your jurisdiction of residence or work.

Our Products are only directed to persons of the age of 18 or over. We do not knowingly collect any personal information from children under 16.
